The Shared Value Project began in Australia in 2014, some three years after Mark Kramer and Professor Michael Porter, won the McKinsey award for their seminal paper 'Creating Shared Value' - in the Harvard Business Review. Their thinking set off rumblings within the business community regarding the role it could, and should, play in contributing to a more sustainable and equitable world.

Over time, and after a lot of hard work, those rumblings have since turned into a crescendo, and companies are now examining their role and societal purpose like never before.

Shared value is not for everyone, it's not a talent acquisition tool (although it will attract top talent), it's not a marketing campaign (although it will provide you with genuine stories to tell) and it's not a reporting framework (although it will give you tangible data).
